



## Letter from the President

This fall marks the 78th anniversary of the creation of The Ithaca Foundation, which created an enduring

fund "designed to encourage and support character, health, building, educational, recreational and welfare activities in the larger Ithaca community." In 1961 The Ithaca Foundation became The Tompkins County Foundation, recognizing the entire community that benefits from its work, and in 2007 The Tompkins County Foundation became The Legacy Foundation of Tompkins County in recognition of the organization's long history and long-term view of its place in the community. Our founders understood how critical support was for our non-profit community and how that support was directly linked to the quality of life in Tompkins County. I am amazed and in awe of their foresight, and I along with our other Board members are very honored to continue the work of the Legacy Board.

What many people may not know is that we are a private foundation but unusual in that our endowment was not created with one large gift as is the case with most private foundations. Our founders created a fund that was built by the community at large, one generous gift at a time. And through the years, it is this endowment fund that is now able to award critical grants that help our non-profit community make a strong community for us all.

Legacy has played a key role as a funder in Tompkins County responding to the needs of our community. Our endowment supports all the giving we do. But the needs in our community have increased over the years and if we want to continue to serve our community now and for future generations, building our endowment must be a top priority. With all this in mind, I am happy to announce the board's decision to embark on an Endowment Campaign in honor of our upcoming 80th anniversary in 2025. We will be sharing more information about this effort in the coming months.

### The Legacy Foundation of

Tompkins County is a private foundation committed to improving the quality of life in Tompkins County by supporting non-profit organizations through semi-annual grant awards. Funding for grants comes from our endowment that continues to grow from careful management by our board, and donations and planned gifts from our generous community. We invite those organizations needing assistance to apply for support, and we invite those community members who love Tompkins County and the quality of life it strives to provide for its citizens, to join our efforts by making a gift to Legacy.

Our History In 1945, five publicspirited businessmen, Paul Brainard, William Burns, Sherman Peer, George Rogalsky, and Gerald Williams dreamt of a way to provide for the betterment of the community that they had grown to love. They decided to create an endowment that would support worthy organizations that make our community a caring and vibrant place to live. Gifts poured in from local residents, and soon grants were being awarded, fulfilling the goals and dreams of the original founders. Those dreams and goals continued to be stewarded today by Legacy's dedicated board of directors.

With the continued generosity of the community, and well-managed investments, the Legacy Foundation's endowment now supports two grant cycles annually that award over \$200,000 to worthy Tompkins County organizations. Legacy continues to follow the vision of the founders, working to make our community a better place for us all.

#### **Our 2023 Grantees**

The Legacy Foundation supports programs, projects, and capital expenditures in the areas of: Health, Education, Recreation, Human and Social Services, Aging, and the Arts. Support may also be given to requests for "seed" money for new or innovative projects or programs.

Legacy Foundation also provides endowment funds for two award programs created by Tompkins Trust Company, now Tompkins Community Bank. The James J. Byrnes Awards for Excellence identifies and rewards excellence in volunteering within Tompkins County, and the Raymond Van Houtte Education Awards, identifies and rewards outstanding teachers and other employees of Tompkins County schools.

#### SPRING CYCLE

**Alcohol & Drug Council of Tompkins County:** Grant supplied the funds for bedding in the new 40-bed detox facility.

**Catholic Charities Tompkins/Tioga:** The grant supported unfunded Community Habilitation services for people with disabilities.

**Caroline After School Program:** Funds supported the purchase of new technology for the program.

**Cayuga Medical Center Foundation:** The grant helped to support the creation of a training center for medical professionals.

**Enfield Community Council:** The grant supported the purchase of a new laptop, software, a projector, and a tablet – all to enable program expansion for the Community Center.

**Finger Lakes ReUse:** The funds will help support infrastructure improvements that will help address the growing demand for reuse services in our community.

**Groton Community Cupboard:** The grant helped to underwrite some of the costs associated with moving to a new facility that will better serve the community.

### Groundswell Center for Local Food & Farming:

Funding purchased tool kits for new farmers to the program.

### Hospicare & Palliative Care Services of Tompkins

**County:** The grant helped to cover costs for patients in the residence so no one is turned away for lack of funds.

## Human Services Coalition (HSC) of Tompkins County:

The funding supported

outreach events for new populations that are struggling with housing issues and not aware of the assistance available through the HSC.

Ithaca Public Education Initiative (IPEI): This funding helped to support the Student Leadership Grant Program.



**Kitchen Theatre Company:** This funding supported the joint production by the Kitchen and Hangar Theatres of "What the Constitution Means to Me."

**LifeLong -Tompkins County Sr. Citizens' Council:** The grant supported technology upgrades and the creation of a video that will be used to expand and inform the community about LifeLong programs.

**New Roots Charter School:** Funding supported the school's Youth Ecological Restoration Corp, which provides students with employment and educational opportunities in restoring the wetlands of Cayuga Lake

**Paleontological Research Institution:** This grant helped to underwrite the replacement of the roof over the Specimen Collections Wing.





Racker: Funds were used to purchase specialized sensory therapy equipment.

State Theatre of Ithaca: Supported the renovation and expansion of the theatre lobby which includes an ADA accessible entrance.

#### Sciencenter:

Funds were used to develop an exhibit called "Changing Skies Gallery" that focuses on changing climate and the impact on weather.



Youth Farm Project: Funds were used to support a summer agricultural work-training program for teens of all cultural backgrounds.

YMCA of Ithaca & Tompkins County: The grant helped to fund the purchase of new ADA pool entry stairs.

**Beverly Martin School PTA:** The grant will contribute to an emergency fund that provides support for families in need.

**Child Development Council:** Funds will be used to support the Basic Needs Program for families.

**Community Science Institute:** Funds will be used for the Volunteers in Precipitation Monitoring program.

**Family and Children's Service:** Grant will support the KINECT program for at risk youth.

Finger Lakes Land Trust: The grant will help cover the cost of purchasing wetlands and stream banks that protect Cayuga Lake's water quality.

**First Congregational Church:** Funded the purchase of an Automated External Defibrillator and first aid kit.

**Food Bank of the Southern Tier:** Funds will support a school food center in Tompkins County.

**Foodnet Meals on Wheels:** Funding will purchase technology to support educational opportunities for participants of the Senior Social Connections Program.

**Golden Opportunity:** Funding will cover an afterschool enrichment and tutoring program.

**Greater Ithaca Activities Center:** The grant will help cover the costs the Hospitality Employment Training Program.

**Habitat for Humanity:** The grant will help cover costs for a historic renovation on Aurora St. in Ithaca.

**Ithaca Community Orchestra:** The grant will help cover the costs of the Fall Concert.

**Ithaca Community Recovery:** Funding will cover the costs of new chairs for meeting rooms.

**Ithaca Health Alliance:** Funds will be used to upgrade the laundry facility for the clinic.

**Ithaca Neighborhood Housing Services:** Grant will help to fund the Minor Repair Program.

#### **Ithaca Welcomes Refugees:**

The grant will help cover the costs of small household items and groceries for newly arriving refugees.

**Love Living at Home:** Grant will help with costs of setting up an office space with better community access.

Running to Places Theatre
Company: Funds will help
underwrite productions so they
can be free for kids to participate
and free for people to attend.

**Southside Community Center:** Funding will cover repairs to agency van.

**Tompkins Learning Partners:** Supported their communications and technology upgrades.

**United Way of Tompkins County:** Funds will help with expansion of the Volunteer Tompkins platform.

Varna United Methodist Church: The grant will cover the costs of purchasing yarn so the Pew Knitters can make gloves, hats, mitten and lap blankets for people in need in the community.



Wharton Studio Museum: Funds will underwrite interpretive signage at Stewart Park.

Women's Opportunity Center: The grant will help cover the costs of renovations to the front entrance.








### Grantee Spotlight: Kitchen Theatre





In 1991, the Kitchen Theatre Company was created as a place where talented young artists could work together and hone their craft. Early productions were high energy and explored how we see the world. From the very beginning, thought-provoking

works, and a commitment to a robust connection with the audience was infused into all the work presented. After 32 years, and over 200 productions, that still is the case. The Kitchen Theatre's tagline – Important Conversation Happen in the Kitchen – remains the guiding light of all the work presented.

The post-pandemic time brought critical challenges. Audiences were used to staying home during Covid and are just now starting to return. Leadership at the Kitchen Theatre knew that to survive and thrive in this post-pandemic world restructuring and re-imagining would be key.

Artistic Director Emerita Rachel Lampert stepped back into Leadership, alongside former KTC staff members Stephen Nunley, Lesley Greene and

Karl Gregory as volunteers, to help the theatre during the transition out of the pandemic. "We needed to re-think things. We convened focus groups and met with other performing arts organizations. It was a great opportunity to think outside the box. Going forward we have shifted our programming and created partnerships, for example co-producing with the Hangar Theatre, that will help us be stronger and financially viable going forward" says Lampert. "We finished our 2023/24 Season with sold out houses. Seeing audiences returning is the vote of confidence we needed."

The Legacy Foundation has supported the Kitchen Theatre with several grants over the years, including underwriting their internship program and helping to fund a collaborative production with the Hangar Theatre

this past Spring. Legacy is proud to be able to support the Kitchen Theatre and their important conversations for our community.

# Donor Spotlight: Jim and Terry Byrnes

In 1988, Jim and Terry Byrnes moved to Ithaca. Jim was hired to be the new president of Tompkins Trust Company, now known as Tompkins Community Bank. It was a coming home of sorts as Jim had attended Cornell and Terry's father was a Cornellian.

As the new president of Tompkins Trust
Company, Jim had a seat on the Tompkins
County Foundation board, now known as The
Legacy Foundation. Both he and Terry are very
community minded, and the work of the Legacy
Foundation – funding non-profit organizations
that make our community a better place to
live – resonated with them both immediately.
Jim quickly became very involved with the
community through his work as President of the Bank, as
well as through the work he did at Legacy.

Terry had also been working in the banking industry, but since she was moving to a new community with a young child, she decided to get involved by volunteering. She joined the hospital board and served on her son's school PTA. Later Terry became instrumental in the creation of the Ithaca Public Education Initiative (IPEI) and its program, Kids Discover the Trail!. Terry's main interest has always been education.

Jim served on the Legacy Foundation Board of Directors from 1989 until 2006. "The Foundation gave me the opportunity to learn about our non-profit sector in depth" says Jim, "I felt that the mission of the bank and the mission of the Foundation had much in common."

Jim retired from Tompkins Trust Company in 2014 and they now split their time between Ithaca and Florida. As annual donors to the Legacy Foundation, their



commitment to the Ithaca community and the work of the Foundation remains strong. "Supporting the Foundation is very important to both of us," says Jim, "because making a gift to Legacy ensures that the money will be used locally to help this community." (Legacy serves Tompkins County exclusively.) "I know first-hand that the board conducts a careful review of all the grants submitted and considers the health of the community as a whole when making awards. That is important to us as well."

Jim and Terry look at their giving as a way to show their affection for a community to which they have strong ties. They feel their giving will be well-stewarded and will help those future community members yet to come. They were once new to Ithaca and Tompkins County and want others settling here to find the same caring and welcoming community they did.

The Legacy Foundation is grateful to have such wonderful supporters like Jim and Terry!


#### James J. Byrnes Awards for Excellence


Established in 1985, the Tompkins Community Bank's (formerly the Tompkins Trust Company) Awards for Excellence program was created with a generous gift to the Legacy Foundation in celebration of the bank's 150th anniversary. The program recognizes outstanding contributions to the quality of life in Tompkins County through religious, charitable, scientific, educational, artistic, literary, or civic achievement.

In 2014, to recognize and honor James J. Byrnes' retirement as Chairman of the Board of Tompkins Financial Corporation and Tompkins Trust Company, the name was changed to the James J. Byrnes Awards for Excellence, and an additional gift was made in his honor. Nominations are submitted by community members, and awards winners are selected by a committee of Legacy and Tompkins Community Bank representatives. Presentations are held annually in the spring.
